# 3-YEAR TP WARRANTY



We hope you enjoy using your new TP Wood Chipper and that it meets all of your expectations with regard to reliability and efficiency.

For greater peace of mind, your purchase also comes with our unique 3-year TP WARRANTY. The warranty is valid for three years from the date of purchase or for up to 1,000 service hours (depending on which comes first).

## 3-YEAR TP WARRANTY ON ALL MACHINE COMPONENTS

– not including wearing parts

The 3-year TP WARRANTY covers all of the components in your TP Wood Chipper, regardless of whether the parts were manufactured in our own factory or came from a subcontractor. This means that we take responsibility for the machine's overall quality and reliability.

- The warranty covers the delivery of new components and spare parts in case of faults or defects in construction, materials or manufacturing, not including the costs of labour, storage and transport associated with the repair.
- You can freely choose a service centre for the regular servicing and maintenance of your wood chipper as long as the centre only uses original TP spare parts and wearing parts.
- NB: The warranty does NOT cover wearing parts. Wearing parts includes filters, belts, couplings, oils and liquids, glow plugs, bearings, knives, counterknives, scrapers, replaceable casing, PTO shafts, ejector spouts, ejector wings, batteries and other parts exposed to normal wear and tear. Surface treatment is also not covered by the warranty.

In case of a warranty matter, please contact the dealer where you purchased the machine.

### THE WARRANTY COMES WITH CERTAIN CONDITIONS THAT YOU MUST COMPLY WITH

The 3-year TP WARRANTY requires that you com-

ply with the following throughout the warranty period:

- Use only original TP spare parts and wearing parts
- Comply with all of the service checks, cf. the manual. Documentation of your service checks must be submitted in any warranty claim

In the case of any warranty matters, you must produce the original invoice containing the date of sale, machine number, machine type, machine model, customer name and address, and the name and address of the dealer.

The 3-year TP WARRANTY is void when a fault or defect has been caused by the incorrect fitting of spare parts or wearing parts, unauthorised changes to the machine or inappropriate use.
